# SECTION 5: FIREFIGHTING MEASURES

#### 5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. In the case of inflammation as a result of improper manipulation, storage or use preferably use polyvalent powder extinguishers (ABC powder), in accordance with the Regulation on fire protection systems. Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection.
